- New pharmacist orientation and training: Standardize and streamline training content and process
- Pharmacy Resident training: Collaborate with pharmacists, residents and residency program directors to develop cohesive and practical training program.
- Institutional IPPE program: Re-design rotation schedule and plan to include other pharmacy staff and area specialists; improve student experience and increase staff participation in IPPE program.

- Continuous Renal Replacement Therapy (CRRT): Develop new order process and convert to commercially available CRRT solutions to reduce errors and improve efficiency
- Systems Trigger Tool: Design and implement new pneumococcal vaccine trigger tool in electronic medical record to improve vaccination rate and quality of care
